## Sam's Marine and Performance 2026 Winterization Contract

### Sam's Marine and Performance:

1. **Will not winterize any watercraft without a signed contract.**
2. **Will not winterize any watercraft with an outstanding account balance.**
3. Will not be responsible for winterizing warranty after 8 months from date of winterizing.
4. Will not be responsible for damage due to floods. Emergency flood summerizing fees may be applied in the event of a flood.
5. Will not be responsible for watercraft sinking on shore.
6. Will not be responsible for damage caused by freezing when a watercraft is requested to be summerized before May 1<sup>st</sup>, 2027 or before temperature is consistently above 32 degrees Fahrenheit.
7. Will not be responsible for batteries. Batteries are disconnected as part of the winterization service; it is the customer's responsibility to properly attend to batteries once they are disconnected.
8. Will not be responsible for any damage caused by operation or launching of watercraft without being summerized.
9. Will not be responsible for pre-existing freeze damage.
10. Will not be responsible for any damage that may occur to your watercraft prior to being winterized.
11. Will not be responsible for any winterizing services performed AFTER the first fall season freeze. The first fall season freeze is defined as any day where the temperature reaches 32 degrees Fahrenheit or lower.

Summerizations are first-come, first-served and will be completed in the order in which they are received. An additional fee will be charged if boat has no key or working battery. Please call (651) 439-7001 for availability.
